11/04506/CPO Pipplepen Farm, South Perrott – infill of a 0.65 hectare area with soils and hardcore and restoration to agricultural pasture. PC response – concerns raised that the quantity of soil and hardcore required to fill the site will necessitate the movement of over 1,000 lorry-loads through South Perrott.
